Stephen krashen described affective filter as a variables that contribute to second language acquisition. According to Merriam Webster dictionary "referring to, arising from, or influencing feelings or emotions." The affective filter has commonly been described as an imaginary wall that rises in the mind and prevents input, thus blocking cognition. In opposition, when the affective filter is lowered, the feeling of safety is high, and language acquisition occurs.

Convergence accommodation is used to seek approval or respect from others, show respect to others and increase social respect to other. Divergence is used To emphasise difference and distinctiveness from others, to show specific to a belonging groups, to influence others speech.

Accommodation theory has a wide range of criticism for its class biasness or racist character of conversation. In this theory when someone joined in a conversation he use the words based on the class, he express his body language according to people who are talking to. In this theory some linguist have alleaged about the violation of general gentleness.
